The UGC vide its letter 4th cited, conveyed the approval of the Government of India, Ministry of Human Resource Development vide letter 3rd cited, regarding revision of the allowances of the Non-Teaching employees of the Central Universities (CUs), as per recommendations of 7th Central Pay Commission with effect from 1st July, 2017.

2. The above revision of the allowances has been made applicable to the regularly appointed Non-Teaching employees and other category of employees viz. Model School Teachers and Instructors of Polytechnic/ITI's in MANUU subject to the following conditions:

- i) The allowances with revised rates shall be effective from 01.07.2017.
- ii) Payment of arrears will be released after the funds for the purpose are provided by the UGC to MANUU.
- iii) A copy of MHRD / UGC letters cited are enclosed for information.
- iv) The Finance Officer may release the allowances with revised rates to the regular Non-Teaching employees and other category of employees viz. Model School Teachers and Instructors of Polytechnic/ITI's in MANUU for the month of May, 2019 onwards.


Dear Sir/Madam,

In continuation of this Ministry's letter of even number dated 2nd January, 2018 it is informed that the Government of India has decided in consultation with the Ministry of Finance (Department of Expenditure) to revise the rate of allowances of non-teaching employees of the Central Universities (CUs) under the administrative control of MHRD on the basis of recommendations of the 7th CPC with effect from 1st July, 2017.
