1	Manufacturing and fixing of Exhibition shelves/Cup boards with bottom storage space with side hung shutters and top display space with sliding glass shutters. It shall be made out of 18 mm thick exterior grade BWR commercial ply confirming to IS 303 for sides top, bottoms, shelves and shutters, 8 mm thick backing ply and 5.50 mm glass for sliding shutters. It shall be fixed with 3 mm thick teak veneer to the exposed surfaces including finishing with two or more coats of French spirit polish and all joinery fittings like SS hinges, handles, channels, runners etc., complete all as per the approved drawings and direction of Engineer-in-charge. 

### Terms & Conditions of the Manufacturing of furniture items:

- The scope of work shall consist of manufacturing and fixing of Exhibition shelves/Cup boards and all other fixtures as per the Schedule of Quantities and attached drawings.
- The contractor shall be registered with CPWD/State PWD/Central/State Autonomous bodies in the furniture category.
- Eligibility criteria for Non-registered contractors:
  - The agency should have a valid Trade license/ registration with the Registrar of Companies, Telangana.
  - ii. The agency should have a valid GST, PAN/TIN registration.
  - iii. The agency should be in the field of Manufacturing of furniture items for the last three years.
- Documentary proof for the Eligibility criteria as per Para 2 should be enclosed along with quotation with self-attestation.
- 4. Earnest Money amounting to Rs.5,000/-(Rupees Five thousand only) in the form of Treasury Challan or Demand Draft or Pay order or Banker's Cheque or Deposit at Call Receipt or Fixed Deposit Receipt (drawn in favour of Finance Officer, MANUU, Hyderabad) should be submitted along with quotations.
- Security Deposit amounting to 5% of the quoted amount shall be deducted from the gross amount of bills and will be held as security for 3 months against any manufacturing defects.
- The time allowed for completion of the work is 15 days.
- The Agency should get the brand and specifications of the Plywood & other fixtures approved by the Engineer-in-Charge before installation.
- The rates quoted should include GST and other levies, if any, and nothing extra shall be paid other than the quoted rate.
- The Income tax and GST shall be deducted from the gross amount of the bill as per applicable and notified by Govt, of India.
- The contractor has to make his own arrangements for water and power etc., which is required for the execution of the work.
- In case of any dispute, Hyderabad will be the Jurisdiction and the Registrar, Maulana Azad National Urdu University, Hyderabad shall decide the issue and his decision will be final and shall be binding on the both parties.
